Building Success



At Boys & Girls Village, we consistently strive to improve the lives of the children and families we serve. Performance Quality Improvement serves as the foundation for a commitment that BGV rigorously upholds: to continuously innovate, expand and improve the quality of the services we provide.

The Board of Directors and staff routinely evaluate our programs, policies and procedures to best ensure that BGV clients are receiving the highest quality care. We review internal measures to monitor performance and to help identify how we can improve services. Some of the measures we look at include increases or decreases in functioning ability, problem severity, arrests or hospitalizations, school attendance and family satisfaction

Our Therapeutic Foster Care (TFC) program served a total of 94 youth - 87% of those youth are still in placement with their foster family or have been discharged into a permanent living situation. The children in foster and kinship care are also well above the national average for graduating high school and continuing their education. In 2014, a BGV TFC Care Manager saw three long-term clients advance to a four-year college, one to community college, and one graduate from high school and attend a construction trade job training program, where he will have the opportunity to earn his professional license.

At the Charles F. Hayden School, BGV's comprehensive, educational and clinical day school, we successfully transitioned more than 10 students back to their community schools. Some of our students have advanced to specialized programs, such as the Bridgeport Military Academy.

To gauge our In-Home Child and Adolescent Psychiatric Service program, we measure the number of children we are able to keep in their family home and develop ways to strengthen those family ties. Our program served over 150 clients last year and our presence in their everyday environment provides us with the opportunity to employ a multi-domain approach to therapy. As a result, more kids than ever are making real, tangible progress in their education and their family lives. One of our children, struggling

with depression, had only attended school seven times during the academic calendar. Thanks to BGV, this student now attends school on a daily basis.

When determining success, BGV also looks at the growth of our current programs and the addition of new programs to better serve our clients. In November 2013, we began a partnership with Yale and The Center for Family Justice to launch its "Bridging Program" at The Center's headquarters in Bridgeport. Developed by Yale pediatrician. Andrea Asnes. MD. the Bridging Program is a no-cost, voluntary, short-term program for children who have been sexually abused. The program also works with parents to help them manage and understand their child's abuse.



Foster & Permanency Planning at Boys & Girls Village



The Therapeutic Foster and Kinship Care (TFC) program at Boys & Girls Village currently serves 61 children across the state and matches qualified foster parents with children in the custody of the Connecticut Department of Children and Families (DCF). Through the dedicated efforts of our foster families and staff, BGV's TFC program is helping more children than ever overcome learning. behavioral and emotional challenges.

Over the summer, four TFC program youth participated in the University of Connecticut's First Star Academy at the university's Storrs campus. The four week live-in program earned the students three college credits and provided a firsthand college living experience.

Students took college courses, explored college majors and were mentored by current UConn students and career advisors. BGV is excited to participate in this great program again next summer.

BGV also continues to work with the CT DCF to increase support for "kinship care," a concept that strives to place foster children with relatives or close family friends. BGV recognizes that the safety, permanency and well-being of children and vouth are often best achieved within the context of familiar homes. When foster placement is needed, research shows that children placed with relatives experience much more positive, long term results includina:

- Greater stability and fewer placement disruptions
- Increased opportunities to remain with siblings
- Reduced wait for permanency, increasing the safety of the clients

At times, placing a child with a biological caregiver is not an option. In these cases, we rely on the dedication of our wonderful foster parents. One shining success story is Judith Ortiz, who was highlighted several times over the last year in the media, including feature articles in the Waterbury Republican-American and Meriden Record-Journal. for her exceptional commitment to children in need of a family. Since 2003, Ortiz has fostered 10 different children and in 2011 she adopted four siblings, giving them the gift of a loving forever family.



Another example of the difference that foster parents can make in the lives of at-risk kids is that of Dyshawn Jones. Dyshawn came to BGV when



he was 13 years old after bouncing around more than 10 foster families. Through the TFC program, Dyshawn was matched with veteran foster mother Maude Pendarvis. By stressing what is right and always putting family first. Maude protected Dyshawn, teaching him important life lessons in love, family, hard work, patience and understanding. Under "Grandma" Maude's guidance. Dvshawn turned his life around. He went on to attend college, secure a job, and marry his long-time girlfriend. The two recently gave birth to their first child. You might have caught their story on Channel 3 during National Foster Care Month in May.



While the stories of Maude and Judith are exceptional, BGV is thankful that they do not stand alone. In April, we held our Foster & Adoptive Parent

Boys & Girls Village C.A.R.E.S.

The men and women who work at Boys & Girls Village have a passion for helping others. In addition to their efforts at BGV, many volunteer in communities throughout Connecticut and beyond, working to improve the lives of children and families everywhere.

Our "BGV CARES" committee helps link employees with volunteer opportunities throughout the state. Our staff volunteered with the Special Olympics during the summer, held fresh fruit drives for the homeless during the winter months, and most recently organized a fresh vegetable drive for a local food shelter. BGV CARES also partnered with the Hayden School to make and decorate baked goods for the homeless during the holiday season.

Some staff members have even taken their volunteer efforts international. In May 2014, Weethne Dorvil, a Therapist Assistant at BGV, traveled to the African country of Malawi on a mission trip with the Nyack, NY-based organization Maloto, Established in 2003, Maloto works to bring lasting, positive change to Malawi by working with local partners to develop and support nutritional, educational, and entrepreneurial programs for women and children.

Weethne supported Maloto's "Kwithu Kitchen," a women-owned cooperative that Maloto helped establish with the residents of Mzuzu, Malawi. The group provides meals and educational services for roughly 300 low-income children and orphans in their local community.

Weethne spent much of his time leading informational sessions for adolescents within the community on topics such as safe sex and avoiding substance abuse. He also provided the women of Kwithu with professional guidance, including strategies to help manage teenagers with behavioral issues.

Weethne has been employed with BGV since August of 2012. He says that his work at BGV equipped him with the skills and knowledge necessary for this type of mission work.

"While the Malawi culture might be dramatically different from Connecticut, they still face many of the same issues that we do. My experience working with children and families through Boys & Girls Village empowered me to take what I've learned and apply it to helping those with similar needs in a country thousands of miles away," stated Weethne.

The Charles F. Hayden School is not only succeeding, it's growing. This past spring at the 2014 Graduation Ceremony, BGV celebrated 57 students who excelled in special subject areas advanced to new programs, and continued studies at their local schools. The Hayden School also expanded this fall to include 10th graders. increasing the school's enrollment to 65 students. Over the past year, Hayden School continued to update resources by adding new staff, vocational programs and learning spaces for students. including new computer labs and an art room.

As always, our classes adhere to current state standards and employ a curriculum developed by Hayden School teachers and administrators. In addition to a robust academic program, the Hayden School curriculum focuses on students acquiring real-world experience through vocational education programs. In July 2014, BGV launched a program with Applebee's of Orange, allowing 9th grade students to help Applebee's staff prep the restaurant prior to opening. The Applebee's program, along with "Coffee Break," a weekly coffee shop at BGV managed by students, provides a valuable educational and socialization tool for our students. It offers them the opportunity to engage staff in discussions about job-related skills while also gaining a sense of responsibility, accountability and confidence that can be applied to a future job of their own. BGV is currently working to add more hands-on learning experiences for students throughout the local community, including future opportunities with River Crest Farm of Milford.

BGV knows it is the dedicated men and women of our staff that make us who we are. From our highly structured, sub-acute services on campus, to our intensive care programs, both in-home and throughout the communities we serve. BGV's programs work solely because of the committed. talented professionals on our staff.

"We realize that working with at-risk youth is not always easy, however it comes with great rewards," said Michele Sommer, Vice President of Human Resources at BGV. "Our goal is to provide the same level of support to our staff members that they provide to our children. We are constantly seeking new ideas and implementing work is our "stay interviews." As opposed to new programs to engage our employees, increase their satisfaction, and promote universal health and well-being."

Most recently, we held our annual Staff Appreciation Day in September, an afternoon filled with games, great food and prizes, BGV also hosted potlucks, holiday gatherings, cookie exchanges, food drives and more, BGV's calendar is full of different ways to build camaraderie, support staff and improve the overall health of our employees including plans for sessions on Healthy Eating on the Go" and "Financial Fitness 101."
